## THE PURPOSE OF THE SUBJECT, LEARNING OUTCOMES:

The purpose of the subject is to make students aware of the historic and contingent nature of the current international system through the study of past international systems in world history.

Students who complete the course will

- master basic analytic tools and concepts
- know how to compare different international systems
- have knowledge of the world history before 1500

## SUMMARY OF THE CONTENT OF THE SUBJECT

The course offers a comparative examination of the international systems of major civilizations before 1500. The focus is on the nature and differences of a) unit types and their internal organization, b) the definition of system boundaries, c) the structure of international systems, d) determinants of interaction capacity within and across systems, e) forms of interaction, and f) various social aspects (rules, norms, institutions) characterizing international systems.

## STUDENT'S TASKS AND PLANNED LEARNING ACTIVITIES:

Weekly compulsory readings: (reading, understanding, research questions, terminology, methods)

Group project: (creativity, critical thinking, problem-solving, communication)

Final exam: (general knowledge, analytical thinking, interpretation, terminology, problem-solving)

#### **EVALUATION OF THE SUBJECT:**

Students' performance will be evaluated according to the followings:

1. Group project (40%). Students form research groups to study the differences of international systems and to present their findings.





2. Final exam (60%). At the end of the semester a written final exam that measures the students' conceptual and factual knowledge related to the field.
