EVALUATION OF THE SUBJECT:

After completing the colloquium, the students will receive a test certificate in the exam period for the performance and practice to be performed together. The exam entry is a maximum of 50 points obtained by evaluating the practice and the maximum of 50 points obtained during the examination. The starting point of the colloquium is that the student's score on the internship must be at least 25 points. If the student does not achieve this score in practice, the course is unsuccessful and the student is obliged to re-enter the subject if the subject has been taken as a compulsory subject. If the score on the collocation does not reach 25 points, the exam mark is insufficient and the provisions of these rules shall apply correctly to the correction or completion of the course. In the case of repeated acquisition of the object, the previously obtained practical scores or other partial results are lost and can not be counted in the post-recruitment evaluation.
